You must be onsite to set-up by 9a.m. on Friday August 8th to avoid experiencing long delays waiting for set-up instructions.

If personal vehicle is part of your set-up, please specify it must fit in your space.

Bring a minimum of 100FT. 12GA. All weather heavy duty outdoor extension cord. We will not provide extension cords.

RULES:

- All balances must be paid in cash before set-up.
- You must remain open until 12a.m. on Sunday.
- The sale of alcoholic beverages prohibited.
- Location assigned by discretion of promoter.
- Vendor is responsible for any Georgia sales tax.
- Sell only items listed on agreement.
- NO REFUNDS will be made for any reason (cancellation, removal for cause, act of god)
- Failure to abide by these rules will result in removal from the event and all fees will be forfeited.
- 2 event passes per spot purchased, additional passes must be purchased for \$25 each (NO EXCEPTIONS)
- You must bring suitable containers to handle grease.
- Running water is available on site.

- Vendor will be responsible for any trash in their area, this includes after event move out.
- You must include copy of CERTIFICATE OF INSURANCE along with payment.
